CURRENT SCENARIO

The tragedy of any metropolitan city in India is that the addition of any parking or traffic infrastructure intended to improve traffic flow and/or parking ends up being used for every purpose other than the one for which it was intended:



- Pedestrian pathways are crammed with parked vehicles,
- Public spaces outside the boundary walls of private houses are claimed for the parking of house-owners' cars
- Left Lanes of the Road are blocked from moving traffic by parked vehicles
- On specific days of the week, whole roads in some areas are blocked to hold bazars or festivities.

The tremors from this chaotic situation erupt in parking squabbles that often end in broken limbs, smashed vehicles or even loss of life. Physical assaults capture media attention momentarily, but the underlying reasons are not thoughtfully analysed to provide a workable solution for decongesting the city of Parking chaos.



The problem as a whole points to some basic facts mentioned below which have been pointed out time and again by various experts:


- 1) Improper & Illegal Parking
- 2) On- Street Parking Fees being very low or free.
- 3) Unskilled & untrained people involved in Parking Operation



STEP BY STEP APPROACH

The administration have to take a tough stance and implement best practices and standards that have been tried and tested by many world class cities to tackle and solve this problem of Parking chaos by applying a 4 point **STEPPED** approach of proper Training, Technology, Enforcement, & Pricing.

- Training: Providing Skills Training to the people currently involved in parking operation & management as per International Parking Code of Practice
- 2) **Technology**: Using Integrated & Centralized Smart parking solution having Smart Payment solution, Central Management System, Parking Space Availability Solution
- Enforcement: Carrying out Enforcement of Parking Violations including Penalty Challan Notices, Wheel Clamping, Towing for improper & Illegal Parking
- 4) **Pricing**: On-street Parking to be priced in relation to the circle rate of the area and minimum surface area required for the car.



Enforcement: The Major Challenge in India

The Major Challenge that comes up in the STEPPED approach in India is implementing key element of Enforcement for Parking Violation.

In Indian context, it is the Traffic Police which shoulders the responsibility of Enforcement of Parking Violation along with other Traffic Violations such as:

- Traffic Signal Violation
- Entry Restriction Violation
- Dangerous Driving,
- Drunk Driving
- Yellow Line Violation
- Driving on the wrong side
- Overtaking Violation, etc ...

Hence parking violation enforcement, even though being important, loses out to other Major Traffic Violation enforcement by the Traffic Police.



International Best Practices & Solution

Internationally, Traffic Police have been discharged of the duty of carrying out Parking Violation Enforcement and focus on more important issues of Maintaining Law & Order on the Roads and enforcement of major related Traffic Violations.

The Parking Violation Enforcement should be carried out by specialized Parking Enforcement agencies hired by Civic authorities to work on their behalf.

These Specialized Parking Enforcement Agencies are accountable to the Civic authorities and work on and defined Service Level Agreement.

They are required to have a Centralized, Auditable & Transparent solution along with a Grievance Redress systems and Structured Legal Recourse Process. The Revenue generated by Parking Violation fines are shared between the Civic Authorities and the Parking Enforcement Agency.

Example: United Kingdom

In 2000 the responsibility of Enforcement of Parking Violation was passed on from the Traffic Police to the Local Civic Authority.

Further, The Road Traffic Management Act 2004 permitted local civil authority to enforce Parking Violations by way of hiring Specialized agencies having a pool of Civil Enforcement Officers who are trained & certified for carrying out Parking Violation Enforcement on Public & Private land with help of Centralized, Auditable & Transparent Technology Solution.

This has helped the Civic authorities in achieving their goal of reduction in Traffic Congestion & Pollution and achieve Best value & Financial Sustainability.



INDIAN SCENARIO: PROPOSED SOLUTION

In order to ensure that the Roads are not congested due to Illegal & Improper parking, the administration have to give due attention to enforcement of Parking Violation which could be carried out either by:

- a) Increasing the Traffic Police Strength and segregating a section out of it for Parking Violation or,
- b) Engaging a Specialized Agency to work as extended arm of Traffic police to carry out Parking Violation Enforcement with Centralized, Auditable & Transparent Solution.

Both the options, Increasing of Traffic Police Strength or Engaging a Specialized Agency as an extended arm of Traffic Police, will certainly help in easing out of the traffic congestion on the roads.

However, Increasing the Traffic Police Strength would lead to an added load on the State exchequer in terms of Hiring, Training etc. along with Parking Violation Enforcement Operational Expenditure whereas Engaging a Specialized Agency on similar terms as followed in United Kingdom will not add extra burden on the State exchequer in terms of the same.

CONCLUSION

Hence, the option of Hiring a Specialized Agency as extended arm of the Local Authority as per the model followed in United Kingdom seems to be a better, more reliable & Scalable solution which will serve the goal of achieving decongestion from the roads due to Illegal & Improper parking as well adding to the revenue stream of the local authority for Civic infrastructure Development and reduction on the pollution.

 - ✓ Drive safely and act responsibly while using parking facilities.
 - ✓ Act responsibly towards the staff managing the parking facilities.
 - ✓ Give the Parking Operator opportunity to answer any query.
 - ✓ Use any appeal service provided by the Parking Operator in and honest & fair way.
